2014 Property Tax Rates in CITY OF LAMESA

This notice concerns 2014 property tax rates for CITY OF LAMESA.

It presents information about three tax rates. Last year's tax rate is the actual rate the taxing unit used to determine property taxes last year. This year's *effective* tax rate would impose the same total taxes as last year if you compare properties taxed in both years. This year's *rollback* tax rate is the highest tax rate the taxing unit can set before taxpayers can start tax rollback procedures. In each case these rates are found by dividing the total amount of taxes by the tax base (the total value of taxable property) with adjustments as required by state law. The rates are given per \$100 of property value.

(Maximum rate unless unit publishes notices and holds hearings.)

In the first year a county collects the additional sales tax to reduce property taxes, it must insert the following lines unless its first adjustment was made last year:

- Sales tax adjustment rate	0 /\$100
= Effective tax rate	0.697387 /\$100

This year's rollback tax rate:

Last year's adjusted operating taxes (after subtracting taxes on lost property and adjusting for any transferred function, tax increment financing, state criminal justice mandate, and/or enhanced indigent health care expenditures)	1,781,768
+ This year's adjusted tax base	255,491,850
= This year's effective rate	0.697387 /\$100
x 1.08 = this year's maximum operating rate	0.753177 /\$100
+ This year's debt rate	0 /\$100
= This year's total rollback rate	0.753177 /\$100

A county that collects the additional sales tax to reduce property taxes, including one that collects the tax for the first time this year, must insert the following lines:

- Sales tax adjustment rate	0 /\$100
= Rollback tax rate	0.753177 /\$100

For a county with additional rollback rate for pollution control, insert the following lines:

+ Additional rollback rate for	0 /\$100
= Rollback tax rate	0.753177 /\$100

Statement of Increase/Decrease

If CITY OF LAMESA adopts a 2014 tax rate equal to the effective tax rate of \$ 0.697387 per \$100 of value, taxes would increase compared to 2013 taxes by \$ 10,973.00.
